Subject: July 1, 2008 Cell phone law California

To All Amateur Radio Operators in my Section

The new California State law goes into effect July 1, 2008 which prohibits you to talk on your CELL PHONE. If you are 18 and under. You CAN NOT TALK ON A CELL PHONE OR YOUR AMATEUR RADIO WHILE DRIVING. YOU MUST PULL OFF THE ROAD TO USE EITHER. DON'T GET CAUGHT...BE SAFE.

For 18 years and older....DO NOT DRIVE WHILE USING CELL PHONE UNLESS YOU HAVE AN EAR PIECE (ONE EAR ONLY) You may use your Amateur Radio.

Here is the statement made by the CHP:

CHP POSITION ON THE "HANDS-FREE" WIRELESS TELEPHONE LAWS

CGC has been flooded with opinions on the subject of the "hands-free" wireless telephone laws that go into effect in California on July 1, 2008. However, two readers sent us copies of the following letter from the California Highway Patrol (CHP)that appears to be great news for not just ham radio operators, but two-way users in general.

CGC has verified the authenticity of the following e-mail. Please, no more letters on "hands-free" unless you have breaking news from official sources. We greatly appreciate your input but do not have the staff to summarize all of the views, many from individuals who have not yet seen the CHP letter.

While the following letter is not necessarily binding on non-CHP law enforcement officers, we plan to carry a copy of the letter in our two-way radio equipped vehicles to reduce our chances of becoming a legal test case come July 1.

Again, the law only applies to wireless telephones.
